CONDITIONS OF ENTRY

Background

- 1. The Promoter is Pedder's Shock Absorber Service Pty Ltd (ABN 90 004 848 435) of 6 Bridge Road, Keysborough VIC 3173 and telephone (03) 9706 3500 ("Promoter").
- 2. Information on how to enter this promotion ("Promotion"), mechanics of entry and prizes forms part of the "Conditions of Entry". Entry into this Promotion is deemed acceptance of these Conditions of Entry.

Eligibility
